WHO CAN APPLY?

Active Y.O.U.ers in good standing with their chapter who has **demonstrated** leadership experience and has attended at least two Y.O.U. or Uniteen retreats/rallies. Only a limited number of YOUers can be accepted on staff so send your application early.

WHEN IS THE UNITREAT?

The Unitreat is Sept. 17 – 19, 2010. YOUers who are accepted as staff members must arrive at camp by 5:00 p.m. CT on Friday. The retreat ends at 11:00 a.m. on Sunday. Y.O.U. Unitreat Staff will receive 30 service hours for the weekend. Y.O.U.ers who create Funshops and/or attend pre-planning meetings may acquire additional service hours.

TRAVEL

Y.O.U. staff must travel with their Uniteen group or with an adult 25 years or older. They may not drive themselves to the event. Transportation arrangements are the responsibility of Y.O.U.er and the sponsoring church. Please discuss your travel plans with the Uniteen Leader.

REGISTRATION FEES

Registration fees for Y.O.U. staff will be paid by the Y.O.U.er. In addition, an adult driver attending and staying at the event with a Y.O.U.er must register and pay the appropriate fee by the scheduled deadline.

HOW TO APPLY

Submit the following, **COMPLETED** paperwork by the deadline stated below:

- 4-page Application Form (this includes Y.O.U. Staff Heart Agreement)
 - o must be signed by the Y.O.U.er, a parent or guardian, the Uniteen Leader, the Y.O.U. Sponsor **AND** Minister or Board President.
- 2-page Youth Medical Release form, signed by parent/guardian.
- Cross Point Camp Release Form (Low Ropes), signed by parent/guardian.
(Low Ropes Course: High youth attendance numbers may cause for YOU Support Staff and adults to be unable to participate in the Low Ropes Course due to schedule. Our first priority is for the Uniteens to experience growth & stretch beyond their limitations. I apologize in advance for any disappointment this may cause.)

Incomplete or late applications will be placed on an alternate list and reviewed only if a position becomes available by cancellation – NO EXCEPTIONS.

STAFF APPLICATION DEADLINE – August 10, 2010

Completed applications with all required signatures and accompanying forms must be postmarked by **August 10, 2010**. Apply early, as there are a limited number of positions available. You will be notified by the end of the month whether you have been accepted or placed on the alternate list.
