FEES & DEADLINES

Postmarked by August 16, 2010 - \$150.00
Postmarked after August 17, 2010 - \$175.00

All registrations must be **POSTMARKED** by August 31, 2010
No refunds after 9/1/10. No substitutions after 9/1/10

ADULT LEADERSHIP

- **Two adults** must travel and stay with each group. A minimum of two adults with a ratio of 1:12 per group is required. (i.e. 2 adults for the first 12 Uniteens, and 1 additional adult for each 12 Uniteens thereafter.) Space is limited so please send the only the number of adults needed to meet minimum regional requirements and driving needs.
- For the safety of our youth and in compliance with the guidelines of our Association of Unity Churches, a **background check** must be held on file at the church for all adults attending regional and national events.
- **Co-ed groups** must provide co-ed leadership/chaperons to ensure the correct amount of cabin chaperons.
- **Drivers** for each group must be at least 25 years old with a valid driver's license and good driving record. Seat belts must be provided for & used by ALL occupants of cars & vans.
- **Ropes Course:** High youth attendance numbers may cause for adults to be unable to participate in the Ropes Course due to schedule. Our first priority is for the youth to experience growth & stretch beyond their limitations. I apologize in advance for any disappointment this may cause.
